

NOTES FOR THE CONSULTATION OF THE EXAM CALENDAR 3-Y DEGREE PROGRAMS

The exam timetable is organized in periods that do not coincide with the lessons. Each exam period consists of one or more sessions. The exam timetable allocates 4 exam sessions for all courses; 2 of them are scheduled after the teaching semester, the third and fourth sessions are considered as supplementary sessions. For foreign language courses, 5 exam sessions are scheduled.

Lessons are suspended at mid-semester in both the first and second semester for 1st partial exams. 2nd partial exams are held at the end of the semester. Partial exam dates may or may not coincide with those fixed for general exams.

Students can take exams in all sessions as long as they satisfy the attendance requirements (semester course lessons in the study plan must be finished). For some types of exams and for some courses, there can be some limitations to access the exam sessions.

The exam periods and exam sessions (reference period: October 2026 - September 2027) are scheduled as follows.

(*) In the period 9 - 22 December 2026 an exam session, open to all enrolled students is scheduled for 1/2 compulsory courses per program/year of studies replacing the January – first period – 2027 exam session which, consequently, will not be scheduled.

Starting from the 2026-2027 academic year, an early exam session in the period 9 - 22 December 2026 may be scheduled for elective courses, replacing the January – first period – 2027 exam session which, consequently, will not be scheduled.

(**) for the compulsory courses, compulsory courses chosen by the students, curriculum compulsory courses the second partial exam if written is scheduled in both sessions of the exam

periods scheduled at the end of the teaching period.

Consequently, for the course typologies above, a second partial exam is scheduled:

- **with reference to the first semester**, in the period 20 January to 2 February 2027 **as an alternative** to the one scheduled in the period 7 – 19 January 2027 (or to the one scheduled for the period 9 – 22 December 2026 if it is a call open to all);
- **with reference to the second semester**, in the period 3 – 23 June 2027 **as an alternative** to the one scheduled in the period 17 May – 1 June 2027.

There are rules and limitations to access the second partial exam, for all details check paragraph Exam and partial exam registration procedure in the Guide to the University.

Note

- "Session" refers to both exams of the current academic year and the previous years.
- **The fourth exam session** for II semester courses will be held in **January – second period – 2027**.
- Exam sessions for foreign language courses are scheduled for: October 2026; January – second period, June, July and August/September 2027.
- With reference to the **Bachelor in Global Law**, if a **third-year student** chooses courses belonging to 5-year Integrated Master of Arts in Law, they need to refer to the exam sessions and periods for that study program, which can be found in *Notes for the consultation of the exam calendar* of the Integrated Master of Arts in Law.
- A reserved exam session has been scheduled in December (**9 - 22 December 2026**), for 1st semester courses, open only to students who:
 1. are participating in: Exchange and Free Mover programs abroad in the 2nd semester 2026-2027 academic year;
 2. are Incoming 1st semester (Exchange and single courses for visiting students)
 3. are participating in a curricular internship, including additional internships, abroad or in Italy in January/February 2027 period.

With reference to the reserved exam session please note that students **CANNOT** sit exams for previous year's courses which have not been passed. Only those students whose teaching activities described in points 1 and 3 start before the December to January - second period ends (2 February 2027) can participate.

There is **NO** overlapping between compulsory course exam sessions of the same year, same semester and same 3-year program; therefore no 2 exams on the same day are usually scheduled, except for: December, January – second period (20 January – 2 February 2027), August/September exam periods, as the available days for exams are limited, and the third-year courses of the **Bachelor in Global Law** belonging to the Integrated Master of Arts in Law, whose exam dates are defined according to the exam calendar scheduled for those courses.

Such overlapping rules refer **ONLY** to compulsory courses of the year in which the student is enrolled and do not refer to previous years' exams which have not been passed yet and/or to elective courses.

Exam timetable

The exam timetable for the October 2026 - September 2027 period is published not later than the end of July on the University Internet site at www.unibocconi.it/exams. During the year the timetable of an exam session may be changed (only to a later date or time), in which case students do not need to re-register for the exam since their registration is automatically transferred to the new

timetable. Exam dates are updated daily on the Internet site. Personalized exam timetables can be viewed on the [yoU@B](#) student diary.

The exams are identified in the exam timetable by the following letters:

- **IP** Partial exam
- **S** Written exam
- **O** Oral exam

In addition, regarding the exam period 9-22 December 2026, reserved for specific categories of students:

- **IS** Partial exam
- **SS** Written exam
- **OS** Oral exam
