Course Objectives

The course provides the main analytical tools needed to understand the functioning of national and international policy making. After a brief introduction on the relations and main differences between political science and public policy analysis, in the first part the emphasis is on public policy analysis theory and on the various phases of the policy process (such as formulation, adoption, implementation). The second part focuses on a number of area case studies such as the European Union and Italy, and the tools provided in the first part of the course are used in order to understand specific policy evolutions and changes over the past decades.

Course Methodology

The course will combine lectures and class discussions based both on students' presentations and on specific readings.

He has worked as consultant for several social and cultural NGOs, local Italian public administrations and agencies (among others, Municipality of Berlin, Comune di Alessandria, ASPeF Mantova, Provincia di Milano, Comune di Pavia, Provincia di Pavia, Regione Lombardia), Department of European Affairs (Italian government) and the European Commission (DG Employment and Social Affairs). He holds a Master in Economics and Management of Third Sector Organizations and a PhD in Political Science from the University of Florence.
